The Department received a number of applications from the Government Degree Colleges of the State for grant of Child Care Leave under SRO-232 of 2015 dated 22-07-2015.

A clarification was sought from the Finance Department with regard to the extent of Child Care Leave to be granted to an employee at a time in a year.

The Finance Department vide O.M. No. A/49(83)-Temp-1143 dated 14-12-2015 has opined that as already provided in the SRO 232 of 2015 dated 22-07-2015 under Clause 7 (IV) the Child Care Leave is to be treated like Earned Leave and sanctioned as such.

The maximum period for availing the Child Care Leave at a time too shall be same as is applicable under rules for Earned Leave.

It is reiterated that the Principals of Government Degree Colleges of the State are competent to sanction Earned Leave as per note 6 below the 1st schedule showing authority competent to sanction all kinds of Leave in the Jammu and Kashmir Civil Services (Leave) Rules, 1979.

In view of aforementioned clarification of Finance Department, it is impressed upon all the Principals of Government Degree Colleges of the State to sanction Child Care Leave to the extent as permissible for Earned Leave in the Jammu and Kashmir Civil Services (Leave) Rules, 1979, based on merits of the case and also taking into consideration the academic necessity of the College.
