Subject: Seeking Information under RTI Act, 2009

Sir,

In reference to the SRO 232 dated 22/07/2015 of J and K State Government, a woman employee may be granted Child Care Leave (CCL) by an authority competent to grant leave for a maximum period of 730 days during her entire service for taking care of her two eldest children below the age of eighteen years whether for rearing or for looking after any of their needs, such as education, sickness and the like. Kindly provide following information regarding CCL under RTI Act, 2009:

1. What is the maximum duration a female employee be granted CCL at a time and under which clause is this duration mentioned?
2. What is the provision to sanction CCL for those female employees whose CCL leave shall lapse if they don't get this sanctioned in time i.e., before the age of 18 years of their child?
3. What measures are adopted by the sanctioning authority to give benefit of this SRO to the female employees so that their Child Care Leave does not lapse and they get full benefit of this SRO for the proper rearing and looking after the needs of their children below 18 years of age.
4. CCL is usually denied to a female employee in dire need with an excuse that there is limited staff and there is no substitute to look after her workload, thus leading to harassment to the female employee and thereby, not implementing the SRO made by the State Govt for the benefit of the female employees and compelling them to resort to legal action to get this benefit. To avoid this harassment and delay in sanctioning CCL, what arrangements the sanctioning authority makes to grant CCL to the female employees in time.

I have also enclosed a payment of Rs. 100 in the name of Accounts Officer / Accountant, GGM Science College, Jammu as the fee required under RTI Act for getting the reply within 4 weeks.
