REVISED NOTIFICATION No. 02 / 2020

In the prevailing COVID-19 pandemic, an online urgent the meeting of all Deans and Principals was held on 30.05.2020 under the Convenership of Vice-Chancellor to review the examination schedule. In reference to UGC guidelines, the matter was deliberated threadbare and it was resolved to give some relaxations as a one time exception in anticipation to the existing rules of the University .The following is the modified plan for conduct of terminal semesters, bi-annual and backlog examinations, which is notified for the information of all the concerned students:

A. CONDUCT OF TERMINAL SEMESTER EXAMINATION:

- i. College wise Examinations will be held from **01-07-2020** to **15-07-2020** for all UG 6th Semester Program.
- ii. Examinations of all 6thsemester UG (Hons.)/ Integrated (Hons.)/Integrated B.Ed.-M.Ed. programs and for all PG programs in 4th Semester will be conducted from **01-07-2020** to **15-07-2020** in the respective Schools.
- iii. Detailed date-sheets of the UG programs will be issued by the respective Principals of the concerned Colleges and be uploaded on their respective websites.
- iv. Detailed date-sheets for 6th semester of UG (Hons.)/Integrated (Hons.) and for 4thsemester of PG programs will be issued by Deans of the respective Schools and be uploaded on the University website.

B. CONDUCT OF INTERMEDIATE SEMESTER EXAMINATIONS :

The conduct of Examination and evaluation of 2nd and 4th semesters will be made on the following parameters:

- i. There will be no major Examinations for 2nd and 4th semesters for UG, UG (Hons.), Integrated B.Ed.-M.Ed. & Integrated (Hons.) and 2nd Semester for PG, but only minor (Internal) examinations will be conducted by the respective Schools and Colleges.
- ii. For evaluation purpose, 50% weightage will be given to minor Examination; and 50 % weightage on marks of the preceding semester only (i.e. 1st semester result for 2nd semester students, and 3rdsemester result for 4th semester students).For backlog cases, the result will remain withheld and be updated only on clearing of all the backlogs.
- iii. Minor Examination will be conducted by the respective Schools/Colleges within 10 days of start of classes.

C. CONDUCT OF EXAMINATION FOR STUDENTS HAVING BACKLOG IN 2ND, 4TH AND 5TH (BI-ANNUAL EXAMINATION) SEMESTERS OF ALL UG, UG (HONS.) AND INTEGRATED UG PROGRAMS (INCLUDING B.Ed.-M.Ed. INTEGRATED PROGRAM):

There will be no conduct of Examinations for 2nd, 4th (backlog cases) and 5th (bi-annual) semesters. However, such of the students will be evaluated on the basis of the following parameters:

- i. 50 % weightage from minor Examination score in the said semester.
- ii. 50 % weightage of the result already obtained in the preceding semester only. In case of backlogs, the result be kept withheld and will be updated on clearing of all the backlogs.

D. CONDUCT OF EXAMINATION FOR STUDENTS HAVING BACKLOG IN 2ND SEMESTER FOR ALL PG PROGRAMS:

There will be no conduct of Examinations for 2nd semester (backlog) of **PG Programs, B.Ed. and M.Ed. Programs**. However, such of the students will be evaluated on the basis of the following parameters:

- i. 50 % weightage from minor Examination score in the said semester.
- ii. 50 % weightage of the result in the preceding semester only. In case of backlogs, the result will be kept withheld and will be updated on clearing of all the backlogs.

E. PATTERN OF QUESTION PAPERS FOR 6TH SEMESTER EXAMINATIONS (except for B.Ed.-M.Ed. INTEGRATED PROGRAM):

The following is the modified pattern of the Question Paper for **Major/Minor examinations of all semesters in UG, UG (Hons.) and Integrated programs (excluding B.Ed.-M.Ed. Integrated program):**

- For the **Major (End Semester Examination)**, the pattern of the Question Paper is as follows:
 - i. There will be one question in section A consisting of short answer and very short answer questions (break-up of marks as per the statutes) and this question shall be covering the **UNIT-1 only**.
 - ii. There will be eight questions in section B consisting of two questions from each of the remaining four units of the syllabus.
 - iii. Students have to attempt Question No. 1 of section A, which is **mandatory** and to attempt **any four from** section B.
- **Minor test** shall not be conducted. The marks of the minor test shall be awarded proportionately on the basis of the marks obtained in the End Semester (Major) examination.

F. PATTERN OF QUESTION PAPERS FOR PG 4th SEMESTER EXAMINATION of PG PROGRAM AND 6th SEMESTER OF INTEGRATED B.Ed-M.Ed. PROGRAM:

The following is the modified pattern of the Question Paper for **Major/Minor examinations in 4th semester of all PG programs and 6th Semester of Integrated B.ED-M.ED Program:**

- For the **Major (End Semester Examination)** the pattern of the Question Paper is as follows:
 - i. There will be one question in section A consisting of short answer and very short answer questions (break-up of marks as per the statutes) and this question shall be covering the **UNIT-1 & UNIT-2.**
 - ii. There will be six questions in section B consisting of two questions from each of the remaining three units of the syllabus.
 - iii. Students have to attempt Question No. 1 of section A which is **mandatory** and to **attempt any three** from section B.
- **Minor Test-1** shall be a Home Assignment (if not conducted before lockdown) which can be sent to students through digital mode and also to be evaluated and the marks to be uploaded much before the start of the End Semester (Major) examination.
- **Minor Test-2** shall not be conducted. The marks of the minor test shall be awarded proportionately on the basis of the marks of the End Semester (Major) examination.
- In case of the 6th Semester **B.Ed.-M.Ed. Integrated** program the **sessional work** shall be taken through digital mode or any other mode that the College Principal deems fit and the marks to be uploaded much before the start of the End Semester (Major) examination.

G. PATTERN OF QUESTION PAPERS FOR MAJOR/MINOR EXAMINATIONS in 4th SEMESTER B.ED. AND M.ED. EXAMINATION:

The following is the modified pattern for Question Paper in **Major examinations of all subjects in B.Ed. and M.Ed. Programs:**

- i. There will be one question in section A consisting of 8 very short answer questions and this question will be **from Unit-I only** of the syllabus.
 - ii. There will be five questions in section B consisting of short answer questions (2 Each) from each units.
 - iii. There will be four questions in section C consisting of long answer questions from Unit 2 to 5.
 - iv. Students have to attempt Question No. 1 of section A which is **mandatory** and to attempt **any five** questions from sections B & attempt **any two** questions from Section C.
- **Minor Test-1** shall be a Home Assignment (if not conducted before lockdown) which can be sent to students through digital mode and also to be evaluated and the marks to be uploaded much before the start of the End Semester (Major) examination.

- **Minor Test-2** shall not be conducted. The marks of the minor test shall be awarded proportionately on the basis of the marks of the End Semester (Major) examination.
- In case of the **B.Ed. and M.Ed.** programs the **sessional work** shall be taken through digital mode or any other mode that the College Principal deems fit and the marks to be uploaded much before the start of the End Semester (Major) examination.

H. CONDUCT OF PRACTICAL/ PROJECT /TEACHING PRACTICE EXAMINATIONS:

All Practical/Project/Teaching Practice Examinations will be conducted internally.

I. ATTENDANCE REQUIREMENT:

Regarding the requirement of minimum percentage of attendance, the period of lockdown will be treated as "deemed to be attended" by all the students.

J. PROMOTION TO NEXT SEMESTERS:

In addition to above, every student will be promoted to the next semester. However, such students have to clear the examination of the courses in which they have failed/ remained absent, whenever the examination is held next.

NOTE:

- The above schedule is being implemented only **as one time relaxation of rules**, not to form any precedence for future.
- Principals and Deans will ensure that the guidelines issued by the Government as well as University from time-to-time **for maintaining Social Distancing** during the examinations are adhered to.
- Students are directed to adhere to the guidelines issued by the Government as well as University from time-to-time **for maintaining Social Distancing** during the examinations.
- Students are directed to bring with them their own face mask, hand sanitizer and water bottle to the University/College during examination time.
- Students are also directed to visit the website regularly for any further updates from time-to-time.
