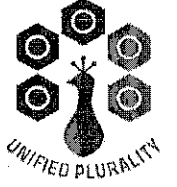

**FOR EMPANELMENT OF REPUTED BOOKPUBLISHERS/SUPPLIERS/VENDORS
FOR FINANCIAL YEAR 2026-2027.**

Dear Sir/Madam,

SUBJECT: Call for the Expression of Interest for empanelment of reputed Book Publishers/Suppliers/Vendors of J&K UT for supply/procurement of books to Library, Govt. Gandhi Memorial Science College Jammu for the year 2026-2027.

As you may be aware, College Library, Govt. Gandhi Memorial Science College Jammu is an esteemed library for teaching and learning for students and faculty. We are in the process of empanelment of Book Publishers/Suppliers/Vendors for the period of financial year 2026-2027.

In this regard, Gandhi Memorial Science College Jammu intends to submit your "Expression of Interest".

Eligibility Criteria: Proof of the following mentioned supporting documents must be enclosed in support of the eligibility criteria and absence of any of them will render the vendors/suppliers ineligible for empanelment:

1. Book Publisher/Supplier/Vendors must be a regular service provider to at least one premium Government Institute of Jammu & Kashmir UT for Higher Education.
2. Registration of Federation of Publishers and Booksellers Association in India (FPBAI) for minimum five years.
3. Permanent Account No. (PAN) issued by the Income Tax Department.
4. Evidence of Income Tax clearance certificate of last three consecutive years.
5. Form-C issued by the Labour Department.

Note: The applicant should read all the terms and conditions properly before submitting the applications for empanelment.

General Terms & Conditions:

1. The applications received after the due date and time will not be considered by the college.
2. All the pages of empanelment documents should be signed and stamped by the firm along with the application.
3. The application must be submitted along with CDR of Rs.5000/- (Five Thousand only) as security deposit drawn from Jammu & Kashmir Bank Ltd. in favor of Principal Govt. Gandhi Memorial Science College Jammu and security deposit will be returned to the supplier after the expiry of the empanelment period. However, in case of unsatisfactory performance during the empanelment period, security deposit will be forfeited.
4. The Firm/Vendor(s)/Book Supplier(s) will furnish self-declaration of an affidavit duly authenticated by 1st class magistrate that the Firm/Vendor(s)/Book Supplier(s) has not been debarred/blacklisted by any University/Institution/College/Government Organization.
5. The college reserves the right to reject or accept any or whole EOI without assigning any reason at any stage.

SPECIAL TERMS AND CONDITIONS

You are required to adhere to the below mentioned terms and conditions:

1. **DISCOUNT:** The eligible publishers/suppliers/vendors shall be empanelled for supplying books on the basis of maximum discount offered by the Book Publishers/Suppliers/Vendors etc. However, in any case the minimum discount shall not be less than 20% on all types of books except Govt. Publications. In case, the rate of discount varies then the highest discount offered will be applicable to all the eligible book suppliers/vendors. However, if any one disagrees the firm can be withdrawn from the empanelment. Further vendor should not compromise with quantity and quality in view of giving maximization of discount.
2. The purchase will only be through local vendors and also from those who are empanelled with cluster university of Jammu.
3. **CONVERSION RATES:** The supplier should submit necessary supporting documents/ good office committee (GOC) conversion rates for foreign books.
4. **EDITION OF BOOKS:** Only latest edition of books shall be supplied.
5. **ORDER ACKNOWLEDGE:** The order should be acknowledged within 10 days from the date of order.
6. **PAPERBACK/HARDBACK:** If paperback editions are not available, then consult the library beforehand if you intend to supply hardback editions.
7. **BOOK SUPPLY TIME:** The maximum time limit for supplying Indian Publication is 15 days and Foreign Publication is 30 days.



8. **BLACK LISTING VENDOR:** In case of non supply of books within the stipulated time for successively three times, the vendor will be removed from the empanelment and blacklisted for future supply, unless the vendor communicates the reason for the delay in supply with valid proof.
9. **ORDER CANCEL:** Order would be treated as cancelled, if the books are not supplied within stipulated time period.
10. **PRICE PROOF:** The supplier shall provide Publisher's Price Proof/Publisher's Catalogue along with the supply of books in support of the price not printed on the books.
11. **TRANSPORTATION CHARGES:** Books must be supplied to the library with No Transportation charges and No other/extra charges are admissible.
12. **PAYMENT:** The final payment shall be made in Indian Rupees within stipulated time from date of receipt of the Invoice, through Online Mode in favour of your agency as per your invoice/s. The final invoices in triplicate shall be submitted along with a photocopy of your agency' PAN Card/GST details/ Bank Account details for the payment.
13. **REPLACEMENT COPY:** In case of Books, if any, received in mutilated/torn condition shall be replaced with a fresh copy.
14. **BILLING ADDRESS:** The bill(s) is/are to be addressed in the name of Principal Govt. Gandhi Memorial Science College Jammu.
15. **ARBITRATION:** In case of any dispute, the same shall be resolved initially by mutual discussion between the parties within a period of 60 days failing which appropriate court at Jammu will have the jurisdiction to adjudicate upon the matter.
16. **MODIFICATIONS:** The college reserves the right to modify/change/delete/add any further terms and conditions prior to issue of agreement.
